Motion by Perraut, seconded by Kendall, the motion unanimously carried to approve minutes of October 10, 2017 Regular Meeting.

Old Business/Action Items

Continued discussion of a 30 year IRB request from Pizza Wholesale of Lexington and Seedtime & Harvest, LLC. Tim Eifler provided letters of support from Pairs-Bourbon County Public Library and Bourbon County Schools. Eifler stated there was no objection with the request however the other districts wanted to discuss during their next board meetings. Fiscal Court is meeting on Thursday, Health and Conservation Districts will be meeting on November 20th and expecting a letter of support from Extension service district any day. Mayor, Thornton emphasized that it is crucial that the Bourbon County Fiscal Court has a full understanding of the request and granted the opportunity to ask questions before the City of Paris makes a decision, also noting that the Fiscal Court can approve the agreement at Thursdays meeting if chosen to do so. Harney stated each time there is a fracture in the line the costs to repair is approximately \$ 2,000 - \$ 2,200 each repair. With the continued and increasing leaks in the area it is of immediate need of attention for repair and the repair is beyond what can be performed by the city.

Motion by Perraut, seconded by Brooks, in favor of declaring an emergency to repair a water line situation in the Southern Hills area. Motion carried by roll call vote of 5-0 with Kendall, Gray, Brooks, Perraut and Thornton voting aye. Bryan Beauman will draft a Resolution declaring the project an emergency.

Fire Chief, Michael Duffy

- The Fire Commission Grant that was applied for has passed phase 1, and now moving into phase 2, he will attend that meeting in Western Kentucky in November.
- Applied for a grant yesterday thru a private organization for the purchase of safety equipment.
