Paris City Commission 525 High Street Paris, KY 40361 Meeting Minutes May 28, 2019

The Paris City Commission met in regular session in the City Commission Chambers at 9:00 a.m. on Tuesday, May 28, 2019.

Mayor, Johnny Plummer called the meeting to order and the Pledge of Allegiance was recited.

City Clerk, Stephanie Settles conducted roll call.

Present: Mayor, Johnny Plummer; Commissioner, Matt Perraut, Commissioner, Wallis Brooks, Commissioner, Stan Galbraith; Commissioner, Anna Allen-Edwards.

Others in Attendance City Manager, Daron Jordan, Assistant City Manager, Mike Withrow, Attorney, Joshua Salsburey.

Upon determining a quorum was present for the transaction of business, City Manager, Daron Jordan proceeded to conduct the meeting.

#### Approve Minutes

Motion by Mayor Plummer, seconded by Galbraith, approving the minutes of May 14, 2019 regular meeting. Motion carried by roll call vote of 5-0 with Allen-Edwards, Galbraith, Perraut and Plummer voting Aye. Brooks Abstained he was not present for the meeting.

### Public Hearing for Use of Municipal Road Aid Funds

Public hearing was held for the use of municipal road aid funds for the FY'20 budget. The floor was open to all for public comment. With no comments either written or verbal received from the public; the hearing was closed.

#### **Public Comment**

Lindell Ormsbee, P.E., Ph.D., D.WRE the Director of Kentucky Water Resources Research Institute with the University of Kentucky spoke about a proposed partnership with water distribution system research.

- KWRRI would provide The City of Paris a baseline water distribution model and introductory training. Provide guidance on how to
  properly calibrate the model and provide a resilience assessment of the system.
  - The City of Paris would provide UK access to updated GIS files of Paris water distribution system including isolation valve data. Allow UK to publish results of analyses of the system while not identifying the system, disguising the actual system and allowing The City of Paris to approve narrative prior to publication, which is expected January 1, 2020.
    - Commissioner Allen-Edwards asked what the cost was for the project. Ormsbee replied there would be no cost to The City of Paris.

Motion by Allen-Edwards, seconded by Brooks, authorizing the city attorney to draft a volunteer agreement and approving the Mayor to sign the agreement between the City of Paris and the University of Kentucky Water Resource Institute for research on the Paris water distribution system. Motion carried by roll call vote of 5-0 with Allen-Edwards, Galbraith, Perraut and Plummer voting Aye. Brooks Abstained he was not present for the meeting.

Ron Carter Chair of HPBC Preservation Committee requested the City of Paris to reactivate the Architectural Review Board, change the demolition permit process, and recognize the three historic districts. Carter said there are no special protections for historic property in Paris, and these requests would create historic overlay zones that can be managed and regulated. Carter asked the Commission to consider enacting an Ordinance related to acceptable historic building maintenance and upkeep and allow the Architectural Review Board to enforce the Ordinance.

# Old Business

Greg Engle of BIM Group insurance broker for the City of Paris discussed the FY'20 employee benefit renewal stating, insurance broker for the City of Paris, discussed the rate and benefit hold for FY'20 budget from Humana, Guardian Dental Insurance, Life and AD&D benefits with Standard Company. Engle stated their will be a rate hold based on a favorable experience rating from the FY'19 budget year.

Motion by Allen-Edwards, seconded by Brooks, based upon the recommendation of Erin Morton approving Humana Health Insurance, Guardian Dental and Vision and Life Insurance, Standard Company Life and AD&D benefits and supplemental benefits and banking to remain with American Fidelity and UMB Bank for FY'20 budget. Motion carried by roll call vote of 5-0 with Allen-Edwards, Galbraith, Perraut and Plummer voting Aye.

Second Reading of adopting the FY'20 Budget Ordinance was read by Bryan Beauman. Motion by Brooks, seconded by Galbraith, approving Ordinance 2019-3 establishing the city of Paris, Kentucky budget for fiscal year July 1, 2019 through June 30, 2020. Motion carried by roll call vote of 5-0 with Allen-Edwards, Galbraith, Brooks, Perraut and Plummer voting Aye.

### City of Paris Ordinance 2019-3

An Ordinance establishing the City of Paris, Kentucky budget for fiscal year July 1, 2019 through June 30, 2020 stimating revenues and resources and appropriating funds for the operation of city government.

Motion carried by roll call vote of 5-0 with Allen-Edwards, Galbraith, Brooks, Perraut and Plummer voting Aye.

# CITY OF PARIS ORDINANCE 2019-5

AN ORDINANCE APPROVING AN AMENDMENT TO THE INTERLOCAL COOPERATIVE AGREEMENT WITH BOURBON COUNTY, CITY OF MILLERSBURG AND CITY OF NORTH MIDDLETOWN FOR A JOINT PLANNING COMMISSION AND RELATED OPERATIONS AND SPECIFICALLY CREATING A JOINT BOARD OF ADJUSTMENT

Whereas, pursuant to KRS Chapters 65, the Cities of Paris, Millersburg and North Middletown and Bourbon County have previously entered into an Interlocal Cooperative Agreement for the operation of a joint planning commission and operations related thereto;

Whereas, the governmental parties desire to make certain revisions to the Interlocal Cooperative Agreement; and

NOW THEREFORE BE IT ORDAINED by the City of Paris City Commission that the proposed amended Inter-Local Cooperative Agreement is approved and adopted; the Mayor is authorized to execute the Agreement and any City representatives are authorized to take action as needed with Bourbon County and the cities of Millersburg and North Middletown and any State official for the proper enactment of this Agreement.

If any provision of this Ordinance for any reason or to any extent, be invalid or unenforceable, the remainder of this Ordinance and the application of such provision to other persons or circumstances shall not be affected thereby, but rather shall be enforced to the greatest extent permitted by law.

This Ordinance was read for the first time on May 14, 2019, and read for the second time on May 28, 2019, and becomes effective on the date of its publication.

Motion by Brooks, seconded by Perraut, approving the purchase of six composite transmission poles and assembly tools for the Claysville right-of-way from Stuart Irby Co for \$ 34,382.56. Motion carried by roll call vote of 5-0 with Allen-Edwards, Galbraith, Brooks, Perraut and Plummer voting Aye.

Motion by Brooks, seconded by Allen-Edwards, approving RFH CPA Consultants to perform an audit of financial statements of governmental activities of The City of Paris FY'19 Budget year beginning July 1, 2018 ending June 30, 2019. Motion carried by roll call vote of 5-0 with Allen-Edwards, Galbraith, Brooks, Perraut and Plummer voting Aye.

Commissioner Allen-Edwards requested auditing of the FY'20 budget year to be published for bid. Daron Jordan concurred.

Motion by Mayor Plummer, seconded by Allen-Edwards, cancelling the regular scheduled meeting on Tuesday, June 25th at 9:00 a.m., and scheduling a Special Meeting for Tuesday, June 25<sup>th</sup> at 6:00 p.m. Motion carried by roll call vote of 5-0 with Allen-Edwards, Galbraith, Brooks, Perraut and Plummer voting Aye.

Commissioner Allen-Edwards requested a two-minute per citizen "listen and learn" session be added on the Tuesday, June 25<sup>th</sup> 6:00 p.m. Special Meeting so citizens could speak to the commission. It was agreed upon that this will be a listen and learn section and would not be a question and answer section all comments would be taken under advisement by the commission.

Motion by Brooks, seconded by Perraut, approving the publishing of an RFP for FY'20 City street paving. Motion carried by roll call vote of 5-0 with Allen-Edwards, Galbraith, Brooks, Perraut and Plummer voting Aye.

Motion by Brooks, seconded by Galbraith, approving a Municipal Road Aid Cooperative Program Agreement and Resolution between the Commonwealth of Kentucky, Transportation Cabinet, Department of Rural and Municipal Aid with the City of Paris for the Fiscal Year beginning July 1, 2019 for a total amount of \$ 171,499.44 with the initial being \$ 99,813.00. Motion carried by roll call vote of 5-0 with Allen-Edwards, Galbraith, Brooks, Perraut and Plummer voting Aye.

First Reading of Ordinance 2019-4 amending the City of Paris annual budget for Fiscal Year July 1, 2018 thru June 30, 2019 estimating revenues and resources and appropriating funds for the operation of City Government was read by Bryan Beauman and Brad Oberlander.
